



## SCHOLARSHIPS AND DISCOUNTS FOR INTERNATIONAL STUDENTS

Graduate fees are for the entire program, covering six (6) semesters in programs with thesis, three (3) semesters in programs with project and twelve (12) semesters in doctoral programs. Scholarships and discounts are applied during registration and they cannot be applied during the education process.

Master Programs	Scholarships/Discounts
Architectural Design	Provided that they meet the necessary requirements in these programs, candidates can benefit from Academic Scholarship, BİLGİ Alumni, BİLGİ Up, Corporate Cooperation/Public/Municipality/ Startup/ Turkish Bar Association and Sibling discounts.  Candidates who are eligible for Academic Scholarship are offered the opportunity to benefit from 2 more discounts apart from the Corporate Cooperation / Public/Municipality/ Startup/ Turkish Bar Association discounts.  Academic Scholarship and Corporate Cooperation / Public/Municipality/ Startup/ Turkish Bar Association discounts cannot be applied at the same time.  Candidates who are not eligible for Academic Scholarship can benefit from a maximum of 2 discounts among all the discounts.  Turkish Bar Association discount can only be used for Law Master's Programs.  The scholarship and discount rate for all candidates cannot exceed 50% in total.

## Scholarships and Discounts

### Academic Scholarship

This scholarship is evaluated by the jury of the preferred program and the results of the evaluation are shared with the eligible candidates. In the determination of the scholarship, the fulfillment of the application requirements specified by the programs, past academic achievements, and projects about the programs are decisive.

### BİLGİ Alumni Discount

Candidates who are BİLGİ alumni can benefit from 30% discount.

### Sibling Discount

If the sibling of the candidate is a BİLGİ alumnus or student, the candidate can benefit from 10% sibling discount. The discount will also apply to the other sibling, effective at the beginning of the next academic year.

### Corporate Cooperation Discount

If the candidate works in one of the corporations with which BİLGİ has established corporate cooperation, the candidate can benefit from corporate cooperation discount. For the discount to be applied, the candidate needs to share their up-to-date personnel document.

### Public/Municipality Discount

Public/Municipality employees can benefit from 35% discount in graduate programs. For the discount to be applied, the candidate needs to share their up-to-date personnel document during registration.

### Startup Discount

The partners and employees of initiatives registered in Technopark, TEKMER, and incubation programs and the employees of Technopark and TEKMERs' operating establishments can benefit from 35% discount.

### Turkish Bar Association Discount

Members of the Turkish Bar Association can benefit from 35% discount for all our Law Master's Programs.

### BİLGİ Up Discount

Candidates who meet the requirements of BİLGİ Up Program can benefit from 40% discount.

### General Rules

Scholarship students are obliged to pay the fee calculated by applying the scholarship rate over the course fee determined by the Board of Trustees in case they repeat the course due to failure.

Registration freeze or disenrollment does not eliminate this payment obligation.
